# **Government Affairs**

# Update on Infrastructure and Budget Bills Brings Hopes and Ongoing Concerns

The infrastructure and reconciliation bills continue to wend their way through the U.S. Congress with the hope of some regulatory relief in one bill and punishing fees for the industry in the other.

GPA Midstream had worked with a group of Republican senators to get expedited permitting for natural gas gathering lines on federal land to open markets and reduce the need to vent and flare. It disappeared from a prior version of the \$1.1 trillion bipartisan infrastructure bill but reemerged in the version that passed the U.S. Senate in August.

The new version, while watered down somewhat in the negotiations phase, provides for a speedier process, but with the caveat that leaves the consideration of expedited permitting in the hands of the U.S. Secretary of the Interior.

Methane emissions, meanwhile, continue as a hot-button issue in another big bill that is holding up a House vote on infrastructure. A resolution for a "blueprint" for the \$3.5 trillion reconciliation bill passed the Senate and the House, forming the framework for what will go in the follow-up budget bill. House leadership has vowed to not vote on infrastructure until the Senate sends the budget reconciliation bill to the House. House votes are tentatively slated for late September.

As mentioned in the July eBrief, there is a proposal in the reconciliation measure that would mean a possible fee on methane emissions that would affect upstream, gathering, processing and transmission companies. If it survives in its current form, the U.S. Department of Treasury would collect \$1,800 per ton of methane emissions from each oil and natural gas basin.

The question is whether it will pass muster with the Senate's Parliamentarian, who reviews the reconciliation bill and strikes out anything that goes beyond the subject scope of what was in the original budget. Application of the so-called "Byrd Rule" can also come as a point of order from the Senate floor.

- The U.S. Army Corps of Engineers and the Environmental Protection Agency (EPA) are soliciting public input on restoring the language and long-standing protections of the Waters of the U.S. to 2015 standards. The restoration of the rules would take into account any changes made necessary by U.S. Supreme Court rulings in the last six years and create a foundation for new rulemaking, which will undergo a second process including public comment.
- The EPA, as part of its listening sessions with stakeholders in the Risk Management Plan Program of the Clean Air Act, received comments from GPA Midstream to rectify 2017 changes that created confusion and inefficiency and keeping 2019 rules that struck a balance. GPA Midstream pointed out that the Risk Management Plan isn't the right place to tackle climate change reduction because it is intended to regulate accidental fires, explosions or catastrophic harm from the release of certain substances, none of which are classified as greenhouse gases.
- GPA Midstream formally objected to the efforts of the U.S. Fish and Wildlife Service to classify the Lesser Prairie-Chicken as an endangered species, despite evidence that populations are stable. A large part of the preservation of the species comes from industry efforts and contributions to conservation programs carried out by landowners in states including Colorado, Kansas, New Mexico, Oklahoma and Texas.

#### **Results of Recent Technical Ballots**

Voting closed on four GPA Midstream Technical Program ballots since the July eBrief. Results of the ballots are as follows:

- Approval Ballot GPA 2103 (Errata): 19 Approve, 0 Negative, 2 Abstain (document published, see details below)
- Approval Ballot Minimizing Emissions During Meter Verifications, Plate Inspections, and Sampling: 9 Approve, 3 Negative, 3 Abstain
- Approval Ballot Simplistic Approach to Leak Detection and Valve Spacing for Liquid Pipelines: 14 Approve, 1 Negative, 0 Abstain
- Workgroup Charter Midstream Property Loss Prevention Guidelines: 12 Approve, 0 Negative, 1 Abstain

We greatly appreciate everyone's participation. Documents will be published after ballot comments have been resolved, and workgroups are initiated upon approval of their charter. - **GPA Midstream Standard:** *GPA-2103 (Errata)* This is an Errata to GPA 2103-20, which includes an equation update.
- GPA Midstream Research Report 249: Effect of Gas Gravity, H2S, and Salinity on the Water Content in Natural Gas: Part III, Effect of Brine GPA Midstream Research Project 074 is a three-part study focused on obtaining new experimental data to benchmark historical correlations based on gas gravity and water salinity provided by McKetta and Wehe (1958). Part I, published as RR-237, reported the relationship between gas gravity and the water content of sweet hydrocarbons. Part III is presented in this report and will address the effect of brines on the water content of methane. Part II will address the effect of hydrogen sulfide on the water content of methane and will be presented in a separate report.
